RE: Coronavirus (COVID-19) Pandemic

Delhi County Water District (DCWD) is actively monitoring the affects and impacts associated with the coronavirus (COVID-19) pandemic. We, like everyone else, are navigating this very fluid and ever-changing situation to the best of our abilities. The District will continue to provide the essential services our customers rely on.

Delhi County Water District is following the current guidance from the Environmental Protection Agency (EPA), the California Department of Public Health (CDPH), the Centers for Disease Control and Prevention (CDC), the Governor's Office (gov.ca.gov) and the Merced County Department of Public Health (MCDPH) to ensure we are taking the appropriate actions to protect our customers, employees and our community.

The following statement was released by the EPA:

"There is no higher priority for EPA than protecting the health and safety of Americans. EPA is providing this important information about COVID-19 as it relates to drinking water and wastewater to provide clarity to the public. The COVID-19 virus has not been detected in drinking-water supplies. Based on current evidence, the risk to water supplies is low. Americans can continue to use and drink water from their tap as usual."

They continued:

"The EPA has established regulations with treatment requirements for public water systems that prevent waterborne pathogens such as viruses from contaminating drinking water and wastewater. COVID-19 is a type of virus that is particularly susceptible to disinfection and standard treatment and disinfectant processes are expected to be effective."

Our water system is continuously monitored by state and federal regulations. We strive successfully meet those standards on an everyday basis and we will continue to do so in these uncertain times. In addition, Delhi CWD is taking the following steps to urge staff to proactively observe the following health guidance to prevent the virus to spread:

• All employees have been educated about proper hygiene and social distancing.

- We have educated staff on the latest CDC guidance on best practices to prevent the virus spread.
- We have minimized or stopped all non-essential travel. Travel considered essential must be pre-approved.
